

## **Refrigerant Tracker Privacy Policy**

### **Gathering and Use of Information You Provide to Verisae, Inc.**

If you want to use the Refrigerant Tracker™ System as hosted on the Site, you will need to create an account. When you create an account with us, we will ask you for the following Personal Information: first and last name, e-mail address (which will function as your user name), physical address, and telephone number. We will also ask you to create a password for your account. Please see our [Terms of Use Agreement](#) for further information regarding passwords. We also may collect Personal Information you choose to send us at any e-mail address provided on the Site. Personal Information may be used for various marketing and/or business purposes including, but not limited to, providing services you have requested, customizing your experience on the Site, resolving disputes, troubleshooting problems, or enforcing our agreements with you. If you already have an account, we will collect additional Personal Information from you regarding your credit card account, such as name, card number, and other information needed to process the transaction. We will then pass over this encrypted information to PayPal to complete the transaction. Verisae does not store or retain any personal information related to credit cards in our system. All financial information is processed and retained in the PayPal system.

### **Gathering and Use of Information Automatically Collected**

When you visit this Site, our Web servers may collect some information automatically, such as your Internet protocol address, the identity of your Internet service provider, your operating system, and the time and date of your visit. This information is not linked to Personal Information. This information is used to compile aggregate statistics about the total number of daily visitors to our Site, the pages most frequently visited and how long visitors tend to stay at each page.
